The park is known to be Garfield Lake Park, 3600 W Mississippi Ave, which is in the City and County of Denver. The victim stated that the suspect threw something at his 7 year old son, and started screaming at his son using racial words. The victim stated he yelled back to defend his son. The victim stated that the suspect went to his house and came back to the park with a hammer, then started chasing the victim, his wife, and 7 year old son swinging the hammer that was in his hand. The victim stated he got his family into his truck and the suspect came to his truck and hit the windshield with his fist and hammer. The victim stated he was in fear of his life as well as his families life.]
