I, Detective D.C. Hardy P99064, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

Your Affiant was assigned case #2018-154467 for follow-up investigation. During the investigation your Affiant obtained the following information: Officer M. Deossie P13086 contacted the Victim, [REDACTED], at his residence at [REDACTED]. The Victim related that on 03-02-18 he was in front of 3985 W. Mosier Pl, which is located in the City and County of Denver, dropping off a check to a co worker and that the Suspect, later identified as Ryan Austin Lee 03-21-76, reached through the passenger side window and punch his passenger (unknown male) with a closed fist. The Victim then related they were able to get out of his vehicle and walked towards his co-worker's home and as the Victim was walking away from the Suspect, the Suspect grabbed the Victim by the back collar and threw him to the ground. The Victim related that while he was on the ground the Suspect was yelling, "get the fuck back to Mexico you fucking wetback" and then proceeded to kick towards the Victim's head. The Victim related that he was able to protect his head with his right arm. The Victim related that the Suspect continued to yell and kick him until the Victim's friends were able to stop the Suspect and they ran inside.

Officer M. Deossie observed the Victim's right arm to be swollen and bruised from approximately his forearm to the middle of his upper arm and that the Victim related that he went to the hospital due to the pain. Officer Deossie noted that the Victim appeared to be in fear of his life and stated that there had been previous incidents where the Victim has been threatened with boards and hammers. Officer Deossie conducted a query of the address that the Victim provided and noted that the resident was Ryan Lee 03-21-76 and that his description matches the description that was provided by the Victim.

Your Affiant spoke with the Victim and he confirmed the statements that he made to the Reporting Officer.

Your Affiant complied a photographic array based on the information provided by Officer Deossie P13086.

Det. R. Brightwell P00110 provided the Victim with the Admonition and the photographic array on 03-09-18 and the Victim positively identified Ryan Austin Lee 03-21-76 as the Suspect who assaulted him
