### AFFIDAVIT AND APPLICATION FOR ARREST WARRANT AND THE ARREST WARRANT FOR THE PERSON(S) OF:

Charles Bisonette 01/28/95 a Hispanic male, 5'3, 122 lbs., Brown hair, Brown eyes.

Sexual Assault with force, 18-3-402 (4)(a), A Class 3 Felony

Sexual assault to an at-risk adult, 18-3-402(1)(a), 18-6.5-108 Class 3 Felony

I, Detective Mary J. 00117, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following:

On November 4, 2017 Officer Hernandez#16075 was dispatched to [REDACTED] Garrison St. Apt. [REDACTED] on a report of a sexual assault. Upon arrival, the officer contacted the victim identified as ([REDACTED] [REDACTED] /85) who stated that the suspect later identified as (Bisonette, Charles 01/28/95) was inside her house located at [REDACTED] Perry Street [REDACTED] which is located in the City and County of Denver. This was on approximately 10/26/17 and she added he began choking her while she was asleep. She then stated he took off her pants and was touching her breasts. He then put his penis in her and she could not do anything but scream. She attempted to push him away and told him to stop multiple times. She was unable to provide any more details due to her mental disability.

The officer spoke to the witness (father of the victim) ([REDACTED]) who stated he witnessed the suspect on top of his daughter. He related the suspect was completely unclothed and had the victim face down on the couch, he was forcing her to bend over. She had no pants or underwear on and was crying and yelling for him stop. Mr. [REDACTED] asked "what the fuck are you doing?" He told him to leave and the suspect fled out the front door. He related he had known the suspect for five years and had visited his home in the past. When asked why he did not call the police then, he stated it was too late and he was too angry at the time.

[REDACTED] (also known as [REDACTED]) stated she had been a family friend for years. Mr. [REDACTED] had dropped the victim off with her about a week ago. Ms. [REDACTED] stated that Mr. [REDACTED] dropped her off about a week ago and told her about the incident and wanted the victim to stay for a few days. Ms. [REDACTED] stated the victim told her what had happened and started to complain about vaginal pain and that it hurt to use the restroom.

Ms. [REDACTED] additionally stated they were at the grocery store and saw the suspect. He reportedly had called [REDACTED] on her phone threatening to rape her and kill her if she called the police. That was when she called 911 to make the report. The victim was transported to Denver Health Medical Center for medical attention and a Sexual assault nurse examination. Additionally, the sane nurse noted that the victim had severe developmental disabilities.

Officer Ruiz reported that she was about to respond to Denver Health Medical Center and [REDACTED] arrived at the apartment. Mr. [REDACTED] rode with the officer in the vehicle and was asked about the suspect. He provided a couple of names that could possibly be "Charlie's" last name and one of them was

Bisonette. The officer pulled up a photograph of Charles Bisonette 01/28/91 and [redacted] positively identified him as the person and had known him for years.

Detective McIver tried to pull up a criminal history on the suspect Charles Bisonette 01/28/91 and there was no record found. There was a driver license photograph and criminal history for Charles Bisonette 01/28/95. In his criminal history, there was a previous arrest for Sexual Assault Contact in Lakewood.

On November 6, 2017 Detective McIver responded to the Denver Children's Advocacy Center to observe the forensic interview and to speak to the witnesses. The driver license for Charles Bisonette 01/28/95 was shown to him and he positively identified it as the same photograph he saw with the officers as the suspect. Additionally he added his daughter is developmentally disabled, and [redacted]

During the interview, she disclosed about the suspect choking her, his name was Charlie, and he put his "weenie in my private" She additionally stated it hurt and did not want to do that and told him to stop and was crying while it was happening.

Detective McIver spoke to Adult protective services and they located a case worked by the name of [redacted] with the Rocky Mouny Human services who had [redacted] as a client. Detective McIver spoke to [redacted] and she forwarded a copy of the waiver of acceptance for services due to [redacted] disability. She was unable to provide medical due to HIPPA requirements.

Based on the aforementioned facts, your Affiant, respectfully requests a probable cause warrant be issued for Charles Bisonette 01/28/95 for Sexaul Assault with force, 18-3-402(4)(a), Class 3 Felony, and Sexual assault to an at-risk adult 18-3-402(1)(a), 18-6.5-108 a Class 3 Felony.
