Statement of Probable Cause Affidavit for Arrest Warrant

On July 17, 2022, at approximately 1:34 a.m., several Denver Police Officers were on duty and working an out-crowd assignment in Lower Downtown Denver as part of their regular duties. Denver Police Officer _____, Officer _____, Officer _____, Officer _____, and Officer _____ were positioned near the intersection of 20th and Larimer St monitoring the crowd as the bars in the area began to close.

Officer _____ observed an altercation evolving between three parties who were standing in front of the Larimer Beer Hall at 2012 Larimer Street. Officer _____ noted that one of the males was approximately 6' tall and wearing a black baseball cap with the White Sox logo. This male was later identified as Jordan Waddy, dob: 12/19/2000. During the altercation, Waddy began to grab at his waist band and lifted up his hoody as though he was armed with a handgun. Officer _____ alerted the other nearby officers of Waddy's actions, and they began to approach Waddy. Waddy turned and began to walk away from the responding officers. The Officer were able to catch up to Waddy as he began to walk in between the vehicles parked on Larimer St. Once Waddy realized there were additional officers approaching from the street, he again turned back and walked in between the parked vehicles and was back on the sidewalk near the Larimer Beer Hall. Officer _____ said he observed Waddy again reaching into his waist band or pocket in a motion consistent with pulling out a firearm. Officer _____ was standing alongside Officer _____ when Officer _____ said that Waddy had a firearm. Officer _____ said he was in fear for his life as Waddy was now armed with a firearm and pointed the firearm in their direction. Officer _____ said he then heard 4 to 6 gunshots and observed Waddy fall to the ground. Officer _____ said he observed Waddy throw the firearm onto the ground.

After the shots were fired, the Denver Police Officers immediately began to render aid to Waddy and several other victim's who were injured during the shooting. Denver Health Paramedics responded to the scene and transported Waddy and other victims to DHMC.

The scene was secured and later processed by Detective Ernest Sandoval along with the Denver Police Crime Scene Unit. In processing the scene, a 10 mm Rock Island M1911 A2 was recovered. The firearm was loaded, one round in the chamber and 7 in the magazine. In searching the bag

carried by Waddy, the crime scene unit investigators found 5 to 10 pills of suspected ecstasy (MDMA).
