The probable cause of the arrest of the above-named individual is as follows:

[Investigation revealed the victim a uniformed Denver Police Officer was interviewing a complainant on a welfare check call in front of location an apartment building. While Officer was interviewing complainant, suspect Neil Hagerty (06-12-65) exited building approached victim/Officer and tore the badge off of Officer's chest. Suspect then used badge pin to cut the throat of Officer causing a [REDACTED]. Simultaneously suspect then attempted to disarm victim/officer by attempting to pull his service weapon(gun)out of the holster. Victim Officer called for cover and on arrival of second Officer suspect continued to fight causing a [REDACTED]. Suspect also attempted to disarm second Officer by attempting to pull Officers Taser from the holster. Both Officer's sustained visible injuries and [REDACTED].
